Saturday school is also starting for intensive tutoring for students to help increase student achievement. Currently at 80% of recommitments from current students. 89 new applications in process. Open enrollment closes February 5th. Since October, 13 classes and 3 teachers have been quarantined – no cases were transmitted in school. DHEC is including an article in the newsletter that will highlight the safety precautions implemented at Mevers.
