III. CSUSA REPORTS

1. Mevers Principal Report

Principal Brenda Coyle reported updates on the CAP and the special education department. Mrs. Coyle also updated the board on the lessons learned this year with the grant process, how to improve for the future, and what to expect with drawdowns before the end of the fiscal year. Mrs. Coyle shared that she had worked hard on the FY22 budget to ensure there would be money added to the fund balance at the end of the year. Mrs. Coyle talked

about culture and how she was working hard to "put the right people on the bus and also put them in the right seats." Lastly, Mrs. Coyle talked about the projected enrollment for FY22 and what Mevers was doing with summer school.

2. Berkeley Preparatory Academy Principal Report

Dr. Roach gave an update on Berkeley Prep. Dr. Roach discussed the different marketing events that are scheduled for BPA. Dr. Roach also shared with the board the names of the newly selected PTC officers: Lynn Solon (President), Donna Yohman (VP), Erlinda Elliot (Secretary), and Amy Ervin (Treasurer). Dr. Roach reminded the board that the BPA dedication would be on August 12, 2021 at 11:00am. Dr. Roach shared an update amount the hiring of staff at BPA and the enrollment.

3. Grants

Susan Gibson, SC State Grants Director, gave an update on the status of grants for Mevers School of Excellence. The board asked that Susan come back to the July board meeting and give an update on ESSER funds and BPA's Planning & Implementation grant.

4. Financials

Stewart Weinberg shared with the board that the BCEA would still not be paying any CSUSA fees, but have been paying 3rd party vendors. Lisanne Morton, CSUSA, was introduced. Lisanne shared that until a new analyst was hired, she would be completing the financials for SC. Corbet Wilson shared that the timing of the physical year end and the grants deadlines. Corbet shared that with the grants the amount of the variance should be better.

 - Taxes and benefits broken out
