- PRINCIPAL'S REPORT

## III. FINANCIAL UPDATE

- AUTHORIZATION TO TRANSFER FUNDS  
**MOTION:** Motion was made by Sandy Hightower and seconded by Cheryl Hollis to authorize the transfer of funds from the board's operating account to the school's operating account in the amount of \$610,457 for September, representing the monthly expenses for the following: Cost & Compensation, Professional Services, Vendor Services, Administrative Expenses, Instructional Expenses, Other Operational Expenses and Fixed Expenses. Motion passed unanimously.

- OLD BUSINESS  
Cheryl Hollis inquired about the communication with parents. Ann Parker indicated that there has not been a large influx of calls.
- NEW BUSINESS

Stewart Weinberg informed the Board that Berkeley county has hired a School Resource Officer (SRO) who is currently in training. There is currently a temporary SRO until the permanent one is available. Also spoke about the location site for the Cane Bay school site working with the Department of Transportation to ensure that the work needed is moving forward to ensure there are multiple entrances for emergency vehicles. Stewart also spoke about the work that will be happening regarding the location in Fort Mill.


