Presented Spring benchmark data PowerPoint I-Ready Summary. Showing winter and spring data by schools. Both schools show growth in reading and math. Both schools have completed the state required testing but will not know data until early fall.

Susan showed major repairs schedule for Mevers and BPA and allow funds to be set aside on an annual basis. Stewart asked for financial staff come up with final number for both buildings.

Stewart and Cheryl expressed darker paint is faded different on the Mevers building. Asked buildings to be power washed.

Mrs. Gibson provided grant updates for both MSE & BPA.

Mr. Coles gave an update on the strategic goals and school report card. Only 9 students required to attend summer program - recommended 22 students participate. Mevers hosted 3 days of spelling bees which was a big success, planning to start it earlier next year. Provided staff updates, recent hires, and current enrollment of 803 students.
